- From consumer reporting agencies, such as your credit history.

HOW WE USE INFORMATION ABOUT YOU

PROMOTIONAL OFFERS

Sometimes we send offers to selected groups of RTX customers on behalf of other businesses. When we do this, we do not give that business your name and address.

INFORMATION DISCLOSURE

We may share customer information as permitted by law. We may share some or all of the information we collect with our affiliated companies and to our service providers, such as third party marketers and other types of service providers we may use to enhance our service to you; to fulfill your requests for financial products and services; to administer your accounts with us; to develop new products and services of value to you; and to offer you other RTX products that we believe may be of interest to you. Our affiliated companies are those companies related to us by common control or ownership.
