YOU ARE ENTITLED TO A COPY OF THE RTX DISCLOSURE GUIDE. PLEASE BE SURE ONE IS PROVIDED TO YOU.

YOUR MEMBERSHIP FEES FOR AN RTX PREMIUM OR RTX PREMIUM PLUS MEMBERSHIP ARE DUE IN FULL AT OR BEFORE THE TIME YOU COMPLETE YOUR ENROLLMENT AS AN RTX PREMIUM OR RTX PREMIUM PLUS MEMBER BY CREATING A MEMBERSHIP ACCOUNT, EITHER ONLINE OR VIA TELEPHONE. RTX DOES NOT PROVIDE FINANCING FOR THE PAYMENT OF MEMBERSHIP FEES. NOTICE OF CANCELLATION

YOU MAY CANCEL YOUR PURCHASE OF AN RTX PREMIUM OR RTX PREMIUM PLUS MEMBERSHIP, WITHOUT ANY PENALTY OR OBLIGATION, WITHIN SEVEN BUSINESS DAYS FROM THE DATE ON WHICH YOU COMPLETE YOUR MEMBERSHIP ENROLLMENT, EITHER ONLINE OR VIA TELEPHONE.

IF YOU CANCEL YOUR RTX PREMIUM OR RTX PREMIUM PLUS MEMBERSHIP USING THIS PROCEDURE, ANY MEMBERSHIP FEES PAID BY YOU SHALL BE REFUNDED WITHIN TEN BUSINESS DAYS FOLLOWING RECEIPT BY RTX OF YOUR CANCELLATION NOTICE. RTX DOES NOT PROVIDE FINANCING FOR THE PAYMENT OF MEMBERSHIP FEES. TO CANCEL YOUR RTX PREMIUM OR RTX PREMIUM PLUS MEMBERSHIP, MAIL OR DELIVER A SIGNED AND DATED COPY OF THIS CANCELLATION NOTICE OR ANY OTHER WRITTEN NOTICE, OR SEND A TELEGRAM, TO RESORT TRAVEL & XCHANGE, LLC, 521 COLLEGE STREET, ASHEVILLE, NC 28801 ATTN: RTX MEMBER SERVICES, NOT LATER THAN MIDNIGHT OF THE SEVENTH BUSINESS DAY FOLLOWING THE DATE ON WHICH YOU COMPLETE YOUR MEMBERSHIP ENROLLMENT STATING THAT YOU WISH TO CANCEL YOUR RTX PREMIUM OR RTX PREMIUM PLUS MEMBERSHIP. ALTERNATIVELY, YOU MAY SEND NOTICE NOT LATER THAN MIDNIGHT OF THE SEVENTH BUSINESS DAY FOLLOWING THE DATE ON WHICH YOU COMPLETE YOUR MEMBERSHIP ENROLLMENT STATING THAT YOU WISH TO CANCEL YOUR RTX PREMIUM OR RTX PREMIUM PLUS MEMBERSHIP TO THE FOLLOWING EMAIL ADDRESS: EXCHANGE@RTX.TRAVEL.
